Call for Nominations ~ Looking For Leaders

It is an opportunity to step into a leadership role on the state level. Our President-elect and 10 District Directors are all active members of the FREA leadership team. As an FREA leader you will have a voice and will be a part of the team making decisions and inspiring other educators throughout the state to support our Mission.

FREA state leaders, are integral to giving us a strong voice in Tallahassee while advocating for our pensions. This is crucial not only to our current retired educators and school personnel, but also future Florida Retirement System (FRS) Retirees. I encourage each member to recognize the importance of serving, or if you cannot serve, please recommend a leader in your Unit to join our FREA Board of Directors leadership team.

Nominations Deadline: December 15 We are currently seeking nominations for the 2026 election – Job Descriptions are available in the FREA Bylaws and Standing rules on the FREA website or by contacting the FREA Office.

Nominations are being sought for FREA President-elect who will serve a two—year term as President-elect, a two-year term as President, and a two-year term on the FREA Board as Nominations Chair.

Nominations are being sought for FREA District Directors. District Directors may serve two, two-year terms (4 years) and **must be nominated each term**. Districts that are open for nomination for new or renewing District Directors are:

District Directors:

District: 1 – Nominee needed
District: 4 – Nominee needed
District: 7 – Nominee needed

Any General FREA member may be considered for President-Elect. Any General FREA member within the districts above may be considered for the District Director. Nominees for these positions must be members in good standing. **Nominations documents:**


- A letter of nomination. **Self-nominations are not accepted.**
- Nominees must be State FREA General Members (not Associate) in good standing
- An acceptance statement from the nominee indicating a willingness to be considered and to serve, if elected.
- If the nominee is NOT already serving in the position, the nomination documentation shall also include a biographical sketch, and a photograph.

All nominating materials should be emailed or mailed by December 15, to: info@frea.org OR

- After the December 15 deadline, should a second Call for Nominations be necessary, that Call for Nominations shall only apply to those positions not having an accepted Nominee.
- After the December 15 deadline, any other nominations shall be made from the floor of the Convention in accordance with Section 9.01 of the FREA Bylaws.
- The documentation received for nominations will be reviewed by the Nominations Committee.
- All nominees will be notified of Committee action.
- Nominees selected for the slate will be contacted for reaffirmation of willingness to serve.
- The biographical sketch and photograph will be published in the Spring issue of the **FREA Bulletin** as required by the FREA Bylaws.

Ballots will be mailed to FREA Unit Delegates on April 23, 2026.
Completed Ballots must be received by the FREA Office no later than May 15, 2026

FREF's 2025-2026 Scholarship Process

Unit Presidents, please make sure that your current FREF Unit Chairs have received the current scholarship information. All FREF Unit Chairs and their local high schools should currently have our 2025-2026 packet.

Please visit the FREA website and check out the Scholarship page. It is the expectation that students with technology will complete the online version of the application. This is the better method, given the fact that using snail mail has caused students to miss deadlines. However, there is a hard copy option for school personnel to access for students who do not have technology. We want everyone to have access to our scholarship application, whether they have technology or not.

Current Scholarship Criteria

- Seniors graduating from an accredited Florida high school (public or private)
- ♦ Unweighted GPA of 3.0 or higher
- ♦ Minimum test scores –SAT 1000 or ACT 22
- **MUST** attend an accredited Florida college/university (public/private).
- MUST teach in Florida, following graduation. A copy of the OFFICIAL FLORIDA PROFESSIONAL TEACHING CERTIFICATE must be sent to the State FREA Office. The scholarship requires recipients to teach in the State of Florida for one year for every year the scholarship was awarded. If not, they <u>must</u> repay any scholarship monies received.

<u>State of Florida Requirement</u>: In order for FREF to maintain our legal status, all scholarship applicants must be granted an interview. If unacceptable, they do not have to be put forward as nominees, but they have to be interviewed.

A Case for COLA

Your FREA Legislative team has been busy this summer. Last year we decided to put all our efforts into reinstating the Coast of Living Adjustment (COLA) for all FRS workers. In 2011 the legislature decided to end


the COLA for 5 years. In the last few years there have been bills concerning bringing back the COLA retroactive to 2011. As you can imagine this proved to be extremely expensive and thus the bills did not pass. FREA adjusted the "ask" to having the Legislators reinstate the COLA at .1% a year of service, with a maximum of 3% and a minimum of 2% after 30 years of service. Without the COLA, the spending power of seniors will be greatly diminished making it difficult to be financially independent. (See the infographic top right.) The FREA Legislative team has spent the summer contacting Legislators at their home offices, discussing the need for a COLA; using the below handout to illustrate the need for a COLA. Hopefully, we will be heard!


Pertinent to the COLA, Committee meetings have already begun at the Capitol. Although we have several Legislators who support our initiative, we have not yet found anyone to write the bill. Currently there are delegation meetings going on throughout the state. Your Legislative team is attending these meetings, talking to the elected officials about the need for COLA and the impact FRS retirees have on the local economy. (See the infographic below right.) Again, we are hopeful that our voices will be heard this year. Please add your voice to our efforts by contacting your Legislators. You can make a difference!

In February, the FREA Legislative team will be in Tallahassee visiting many of your elected Legislators. We will spend two days travelling through the halls of the Capitol speaking to them and attending committee meetings. FREA remains committed to bringing back the COLA. The FRS pension plan is made up of every state employee, with the majority being public education employees. By keeping the FRS viable and strong, we help current and future retirees from bus drivers, to teachers, to policemen, firemen, and so many more. We feel that reinstating the COLA is a win-win situation for the State of Florida, its citizens, and all members of FREA.

Report holiday scams to ic3.gov, the FBI's Internet Crime Complaint

Holiday Scams Tips from the FBI

When shopping online during the holiday season—or any time of year—always be wary of deals that seem too good to be true. Don't become a scammer's next victim.

Every year, thousands of people become victims of holiday scams. Scammers can rob you of hard

-earned money, personal information, and, at the very least, a festive mood.

Scams include:

- Non-delivery scams, where you pay for goods or services you find online, but you never receive your items
- Non-payment scams, where you ship purchased goods or services, but you never receive payment for them
- Auction fraud, where a product you purchase was misrepresented on an auction site
- Gift card fraud, where a seller asks you to pay with a pre-paid card

According to the Internet Crime Complaint Center's (IC3) 2023 report, non-payment and non-delivery scams cost people more than \$309 million that year. Credit card fraud accounted for another \$173 million in losses.

The IC3 receives a large volume of complaints in the early months of each year, suggesting a correlation with the previous holiday season's shopping scams.

If you've been scammed, you should also contact your credit card company or your bank to dispute any suspicious charges.

Protect Yourself

Whether you're the buyer or the seller, there are a number of ways you can protect yourself—and your wallet. Remember: If it seems too good to be true, that's because it is.

Practice good cybersecurity hygiene.

Don't click any suspicious links or attachments in emails, on websites, or on social media. Phishing scams and similar crimes get you to click on links and give up personal information like your name, password, and bank account number. In some cases, you may unknowingly download malware to your device.

Be especially wary if a company asks you to update your password or account information. Look up the company's phone number on your own and call the company.

Know who you're buying from or selling to.

- ♦ Check each website's URL to make sure it's legitimate and secure. A site you're buying from should have https in the web address. If it doesn't, don't enter your information on that site.
- If you're purchasing from a company for the first time, do your research and check reviews.
- Verify the legitimacy of a buyer or seller before moving forward with a purchase. If you're using an online marketplace or auction website, check their feedback rating. Be wary of buyers and sellers with mostly unfavorable feedback ratings or no ratings at all.
- ♦ Avoid sellers who act as authorized dealers or factory representatives of popular items in countries where there would be no such deals.
- ♦ Be wary of sellers who post an auction or advertisement as if they reside in the U.S. but then respond to questions by stating they are out of the country on business, family emergency, or similar reasons.

Avoid buyers who request their purchase be shipped using a certain method to avoid customs or taxes inside another country.

Be careful how you pay.

♦ Never wire money directly to a seller.

Avoid paying for items with pre-paid gift cards. In these scams, a seller will ask you to send them a gift card number and PIN. Instead of using that gift card for your payment, the scammer will steal the funds, and you'll never receive your item.

Use a credit card when shopping online and check your statement regularly. If you see a suspicious transaction, contact your credit card company to dispute the charge.

Monitor the shipping process.

- → Always get tracking numbers for items you buy online, so you can make sure they have been shipped and can follow the
- ♦ Be suspect of any credit card purchases where the address of the cardholder does not match the shipping address when you are selling. Always receive the cardholder's authorization before shipping any products.
